In hotel accounting terminology, "fair" means accurate or objective. A complete set of financial reports includes a balance sheet (otherwise known as statement of financial position), statement of profit and loss (P&L or statement of income), statement of cash flows and statement of equity (also referred to as statement of retained earnings).
